8) Confirm the Pricing Methodology adopted for the proposed preferential issue along with detailed working of the same or Valuation report from independent registered valuer:

The Minimum Issue Price, in terms of Regulation 164(1) read with Chapter V of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 under the Market Price Method, at which Equity Shares are to be issued is ₹ 432.65 (Rupees Four Hundred Thirty-Two and Sixty-Five Paise only). This Preferential Issue will not result in change in control of the Company and also there is no allottee or allottees, acting in concert, to whom allotment of more than 5% of the post issue fully diluted share capital of the Company is proposed to be made. So, the Valuation Report is not applicable to the Company.
